Failure of the school to complete and return this form <u>within 5 business days</u> of student withdrawal or notification of withdrawal will result in the school forfeiting the right to any scholarship payment for that child still owed to the school. Schools are encouraged to return this form prior to student departure whenever possible so final scholarship payments can be processed and received by the school for signature by the parent/guardian A prior to the last day of student attendance. Parent/guardian signature, prior to deposit, is required by law.
